The event will bring together professional health professionals, Counselling Psychologists, Clinical Psychologists, Community Psychologists, Counsellors, Student Counsellors, Social development practitioners, Educators, Researchers, and policy makers from all over Uganda and beyond.

Objectives of the Conference

The 16th Annual Counsellors' Conference aims at attaining the following Objectives:

1. To examine the existing mental health and psychosocial practices, models and interventions, that are being used to enhance the well-being of both refugees and hosts in treatment,

- recovery and building resilience for individuals, families, men, women children and the communities.
- 2. Provide a forum for all counsellors and those providing counselling services to share experiences and best practices in counseling forced migrants, dealing with Mental Health and Gender challenges.
- 3. To situate and advocate for counselling as an integral therapy in handling mental health and psychosocial challenges among the forced migrants and the host communities

We request you to submit your abstract in line with the conference sub-themes as indicated below.

Conference Sub-themes:

- 1. Models that work in the context of forced migration.
- 2. Psychosocial challenges for hosts and refugees.
- 3. Mental health and support for children.
- 4. Gender and Mental health
- 5. Human trafficking and the export of labor
- 6. Caring for the carer

Instructions for abstract submission:

- 1. Your abstract should have **maximum of 300 words**[excluding details of the author(s)]. Please note that the conference abstracts review committee will only accept abstracts which follow the guidelines and which are formally correct (e.g. precise length, no typing errors).
- 2. All abstracts should be written in **Times New Roman, font size 12, single spacing**.
- 3. The presenting author should be indicated first, and then all other authors' names can follow.

- 5. Deadline for abstract submission: 24th February 2020

Please note: Notification of abstract acceptance will be sent to you via e-mail by 6th March 2020.

Guidelines for those intending to submit abstracts for 16th Annual UCA Conference 2020

The Abstract being submitted should fall in any of the following 3 categories (with the respective writing format):

- 1. **Descriptive Abstract**: This can be about a project or a programme. In this case, the writer describes an innovation, which should be counselling related in this case, that the writer deems worth sharing to the Counselling family (Educators, Practitioners, Consumers, Policy makers, students, among others)
 - Title
 - Introduction
 - Programme or Project Description
 - Outcomes
 - Lessons learn
 - Recommendations (for practice and research)

- 2. **Informative abstract:** This is the one from researched work. In this case, a person should have carried out a study about any topic related to the conference sub-themes. So, the person would be wishing to share such research findings to the conference audience. The format for abstracts in this category should have the following:
 - Title
 - Background (should include the problem or gap addressed)
 - Purpose
 - Objectives
 - Methodology
 - Results
 - Conclusion
 - Lessons learnt
 - Recommendations (for education, practice and research)
- 3. **Position paper:** A person could be having a really hot issue that is indeed very relevant to conference theme and profession but does not fall in any of the above categories of abstracts. The person would wish to share knowledge and views on such issue. The abstract in this category should have the following:
 - Background
 - Issues
 - Recommendations
